Foundations of Business class series were held in the winter and spring in all three counties. Business Start-Up Classes were held for contractors. A total of 40 people completed the business planning class series. 5 potential female forestry contractors attended the Contractor Start-Up classes. An additional thirty people attended one-time content specific trainings. NEOEDD also supported 36 Individual Development Account participants

4b (Code:) (Expenses \$ 81,145 including grants of \$ 81,145) (Revenue \$ 708)
NEOEDD partnered with the City of La Grande to operate the IGNITE Center for Entrepreneurship in La Grande. We acquired funding from the Kauffman Foundation through partner Rural Development Initiatives and from Business Oregon through their Rural Opportunity Initiative program to operate the center. Ignite hosts our educational workshops and provides a co-working option in the community. http://www.ignitemybusiness.org/en is the center's website. Center operations were disrupted by COVID-19 in March 2020. NEOEDD started efforts to support businesses impacted by COVID-19. These efforts included supporting a grass-roots effort in Wallowa County to raise funds and distribute them to local businesses. 16 businesses received funding through this effort. We also supported the City of La Grande's emergency loan program by providing loan analysis and generating loan documents. 25 businesses received funding through this effort. 40 people participated in a COVID-relief webinar explaining different federal funding sources. NEOEDD investigated other funding sources and started the process of applying for CDBG pass-through funding for businesses.

As part of our effort to support Diversity, Equity and Inclusion in the region's nonprofits, NEOEDD offered the new two-part Journey to Equity workshop series in La Grande. Five organizations participated in the workshop series. We hosted four Diversity, Equity and Inclusion Roundtables for nonprofits during the year. We also hosted Oregon Humanities conversation projects for the general public. Approximately 100 people participated in these events.

Form 990, Part VI, Section A, Line 7a - Up to 18 members of NEOEDD's board of directors are appointed by county governments. Baker, Union and Wallowa counties are responsible for appointing 6 members, each, to the board of directors. The county governments select two members of their three-person commissions as members of the NEOEDD board. They do not always appoint all of the members they are entitled to appoint. The NEOEDD board itself may appoint an additional 3 members to the board.

Form 990, Part VI, Section B, Line 11b - The draft 990 was distributed to all board members 3 days prior to the filing deadline. If the board members want any changes to the 990 that are not discovered prior to filing, an amended return will be completed and filed.

Form 990, Part VI, Section B, Line 12c - Many board members are also elected officials or government officials and are familiar with conflict of interest rules and attend government ethics training as a routine part of their other positions. This training is also available for all board members. Board members are occasionally in a situation where they might have a perceived conflict of interest. In these situations, the board member would declare a perceived conflict of interest and not vote on the issue. NEOEDD prohibits board members or their families from applying for loan funds while active on the board and for two years following the conclusion of their board service. The board members and staff are all aware of this restriction and staff would not process a loan application if the business was owned by a board member or former board member that met this criteria.

Form 990, Part VI, Section B, Line 15 - NEOEDD hired the Local Government Personnel Institute to identify similar organizations in Oregon and establish comparable wages for all employees in the fall of 2017. The Executive Committee reviewed the salary survey and made a plan to increase salary for nearly all staff as salaries were generally under the minimum amounts paid at other organizations. The salary survey is updated annually by increasing the comparable salaries by the increase in the Consumer Price Index.
